# 2012 Mercuria/NCHA World Series Rules

## SUMMARY

- To be held in Lyon, France – Dates November 2, 3, 4, 2012.
- For any horse/any age.
- Current NCHA Membership required for owner and rider.
- Non-Pro entries must meet NCHA Ownership Rules.

## CLASSES

- The 2012 Mercuria/NCHA World Series will have two classes: Open & Non-Professional. A separate entry form is required for each horse and separate entry fee shall be paid per horse for each class.
- Owners may enter an unlimited number of horses in all classes. Riders may ride two horses in the Open class and one horse in the Non-Professional class.
- \$25,000 will be added to the Open purse and \$25,000 will be added to the Non-Pro purse.
- Entry Fees (includes video fee): Open & Non-Pro (\$870). Entries are to be paid in full and received by October 1, 2012. All entry fees will be made payable by MasterCard, Visa or American Express, cashier's check or money order paid to the order of National Cutting Horse Association in United States Funds or its equivalent. There are no refunds.
- Late Payments: Late entries are allowed after October 1, 2012 and up to the draw with penalty.
- Go-Rounds: At the conclusion of the first go-round only the high scoring twenty-five percent (25%) with a minimum of six (6) and a maximum of twelve (12) plus ties will advance to the finals.
- Finals: The top fifty percent (50%) of finalists will receive a check based on the NCHA unit payout system. All Finalists will receive a base pay of two times the entry fee. All money will be paid in the Finals.
- Judges: Five judges will be named to judge the event by the NCHA and will be under the direct supervision of the NCHA Judges Monitor.
- All rules of the National Cutting Horse Association shall apply.
- A completed NCHA Wire Request form is required with entry form.
- Stalls: 320 Euros per stall. Payment shall be made direct to Equita' Lyon. Please complete the Show Contract of Participation form and remit to Equita' Lyon.
